Reference is invited to this Secretariat letter No. A-10011/45/2015-PPC dated 24.08.2016 and letter No. Misc-001/1(20)/2015-PBRB dated 28.07.2015 regarding eligibility of newly recruited employees of Prasar Bharati who were recruited after 05.10.2007 (Copies enclosed).

2. This Secretariat has received references from employees seeking clarification of applicability of Government Rules/regulations viz Lien, Casual Leave, Technical Resignation, Leave Travel Concession, Travelling Allowance Rules, Transfer Policy etc to PB Employees. Clarifications have been sought from DG:AIR /DG:DDn on rule position on EL encashment , grant of Over Time Allowances etc. for PB Employees.

3. The matter has been re-examined in this Secretariat. Accordingly, it has been again reiterated that as per resolution passed by the Prasar Bharati Board in its first meeting, government rules and regulations would be applicable mutatis mutandis to Prasar Bharati Employees recruited after 05.10.2007 till Prasar Bharati frames its own regulations/policy.

4. This issues with the approval of Competent Authority.

Subject: Eligibility of newly recruited EAs and Technicians in Prasar Bharati -reg.

Reference DG AIR's O.M. No. 14/32/2015-SIVA/484 dated 23.6.2015 on the above subject. Clarification on the points raised therein is given below:

- i. **Accommodation:** The new recruits i.e. Prasar Bharati employees are not eligible for General Pool Accommodation. They are, however, eligible for Prasar Bharati's own accommodation or HRA in lieu thereof;
- ii. **Medical facilities:** They are not eligible for CGHS facilities. However, CS ( MA) Rules would be applicable to them mutatis mutandis;
- iii. **Group Insurance:** There is no Group Insurance Scheme in vogue in Prasar Bharati at present; However, the matter is under examination in Prasar Bharati.
- iv. **Provident Fund and Pension Scheme:** They would be covered under the New Pension Scheme;
- v. **LTC:** They are eligible for LTC. The same Rules as are applicable to Government servants of equivalent status would be applicable to them;
- vi. **Others:** They are eligible for Children education allowance at par with Central Government employees of equivalent status.

It is further informed that as per Resolution passed by the Prasar Bharati Board in its first meeting till Prasar Bharati frames its own Regulations, Government Rules and Regulations would be applicable mutatis mutandis to its employees.
