Subject: Request to issue order to grant Non-Productivity Linked Bonus (Ad-hoc Bonus) to PB Employees for the financial year 2020-2021.

Respected Sir,

With due regards, we want to bring your kind attention on Bonus issue of Prasar Bharati Engineering Employees recruited after 05/10/2007. Sir, as you know that Prasar Bharati employees are getting bonus after the approval of Prasar Bharati Board since last two financial years. We as Prasar Bharati Engineering Employees want to express our gratitude towards your generous gesture of extending benefits of non-productivity linked bonus to Prasar Bharati Employees for financial year 2018-19 and 2019-20. Sir as you know, for the last two years after the Finance Ministry issued the order for bonus, Prasar Bharati also used to issue a separate order to give bonus to Prasar Bharati employees, as a result of which Prasar Bharati employees got bonus.

Sir as you are aware that Finance Ministry has issued orders for Bonus for the year 2020-21 on 18/10/2021 (copy enclosed). But It is very disheartening for Prasar Bharati Employees even after so many days of this order, Prasar Bharati has not issued any order regarding bonus, as a result of which all the Administrative head of Kendra/Station are asking for separate Prasar Bharati order to grant bonus for Prasar Bharati Employees who were recruited after 05/10/2007.

Sir It can be observed in our organization central government employees on deputation and Prasar Bharati employees are on the same post and doing similar work for the department but unfortunately the deemed deputation employees are getting bonus and Prasar Bharati employees are deprived of bonus facility.

This has created a deep sense of apathy amongst the Prasar Bharati Employees since they felt like being discriminated by not issuing order of Bonus from Prasar Bharati.

With the above mentioned facts and figures we request your good self to kindly take necessary steps to grant the Non Productivity Linked Bonus (Ad hoc bonus) for the year 2020-21 before Deepawali festival and so on to the employees of AIR & DD Joined after 05.10.2007 at par with the Central Government employees to avoid and further discrimination on part of payment of Bonus.

An urgent intervention in this issue is requested.
