**Subject: Representation regarding anomalies in ongoing DPC of Engineering Assistant to Senior Engineering Assistant.**

Respected Sir,

With due regards, we want to bring your kind attention on serious issues of EA to SEA Promotion of Prasar Bharati Engineering Employees recruited after 05/10/2007. In this regard your high office conduct a review meeting of DPC to consider the promotion of the post from Engineering Assistant to Senior Engineering Assistant for the year 2009-10 to 2017-18 and a fresh DPC for the year from 1.1.2018 to 31.12.2018 and from 1.1.2019 to 31.12.2019 in North Zone. a vigilance clear certificate is also asked from your good office from all stations of AIR and DD in north zone in respect of 459 employees as per list attached mention at reference 1.

We want to highlight some discrepancies and anomalies in this eligibility list:

1. Eligibility list which has been prepared by zonal offices, Prasar Bharati engineering employees who fulfill the eligibility criteria have not been included.
2. Some EAs who have been promoted from Sr. Technician after 05/10/2007 and Junior to some of EAs, who are recruited after 05/10/2007, has been included in seniority list.



There are many employees in the list who are junior to many EAs who are recruited after 05/10/2007 as joined as EA in 2008 as per seniority list at mentioned at reference 2. Some of example as follows:

It is relevant to mention here that approximately more than 100 EAs are junior to Prasar Bharati EAs who are recruited after 05/10/2007 as per seniority list enclosed and many of them are included in the recent list to consider promotion. It is very painful and disheartening that some Prasar Bharati EAs are deprived of promotions despite being senior.

In view of the facts & justification explained above, it is requested to your high office to remove these anomalies and review the eligibility list of EA to SEA promotion by inclusion of eligible Engineering Assistant who are recruited after 05/10/2007.
