ADGs as detailed below- Upto Rs.2.00 Lakhs ADG (NZ) (Admn.) ADG(SZ) (Admn.) ADG(EZ) (Admn.) ADG(WZ) (Admn.) ADG(NEZ) (Admn.) -For all states under their jurisdiction as per PB Sectt's Office order dated 14.07.2020
2.	Reimbursement for treatment taken with prior permission	(i) Head of Office ** (not below the rank of Deputy Director) – Upto Rs. 2.00 Lakhs (ii) Head of the Department – full powers upto Rs.5.00 Lakhs (iii) HoD with the concurrence of IFD where it is more than Rs. 5.00 Lakhs. (iv) Matter needs to be referred to CGHS/ MoH&FW wherever relaxation of rules is required.
3.	Medical Advance' 90% of estimated expenditure submitted by the hospital (Govt. or empanelled private hospitals by CGHS/ State Government)	(i) Head of Office ** (Not below the rank of Deputy Director) – Upto Rs. 2.00 Lakhs (ii) Head of Department – More than Rs. 2.00 Lakhs
4.	Condonation of delay in submission of MRC	Head of Department
